If an accident occurs, I will not hold Best Buddies financially responsible and either I or my parent/guardian will pay for any medical expenses incurred by me.
 - I understand that I must have one million dollars in liability coverage from my or my parents insurance company in order to transport any Best Buddies participant in my vehicle.
